




SAFETY INSTRUCTIONS

NOTES / RULES On the factory premises

The instructions / rules apply to the entire company premises, to all employees, customers, suppliers, maintenance and repair companies and other visitors.

When you enter the factory premises, the following rules and prohibitions become binding for you.

In the interests of your and our employees' safety, these must be strictly adhered to.

BASIC RULES

Information, prohibition and mandatory signs must be observed.

The maximum s p e e d on the entire factory premises is 5 km/h. The StVO applies on the entire factory premises.

Forklift trucks and industrial trucks always have right of way!

Visitors, suppliers and other external persons must sign in and out at the registration desk or the administration. Unauthorized persons are not permitted to enter buildings and production facilities on the company premises.

Vehicles may only be parked in the designated areas. Driving on the premises without the express permission of the supervisory staff is not permitted.

There is a ban on alcohol, smoking and open flames on the entire site.

The instructions of our staff must be followed at all times.

Children and young people under the age of 18 are only permitted on the premises in the presence of a supervisor or, if necessary, after prior consultation with and permission from the personnel department or foreman.

Due to the hazards involved, PPE must be worn on the entire factory premises. For reasons of hygiene, please bring your own PPE.

The use of the sanitary facilities requires the express permission of the master/supervisor and is at the user's own risk.

LIABILITY

Entering and driving on the company premises is at your own risk.

No liability is assumed for accidents or other damaging events in the entire area of the company, except in cases of willful misconduct or gross negligence.

The driving and accompanying personnel of customers or suppliers are liable for any damage caused by you; the employers/clients of these personnel may also be liable.

NOTES / EXPLANATIONS



Image and sound recordings are prohibited. The use of cell phones or cameras is prohibited on the entire factory premises.



The StVO and walking speed (5km/h) for vehicles apply throughout the factory premises.



Take particular care with industrial trucks on the mixed traffic routes within the buildings.



Safety goggles, safety shoes and hearing protection must be worn in the various areas.



Access for wearers of pacemakers is prohibited in this area.



Alcohol and drug consumption are prohibited.



Smoking and open flames a re prohibited on the entire site.



Observe escape and rescue routes and keep them



Wearing high-visibility vests in production is mandatory!



In an emergency: Leave the building immediately and go to the assembly point. Follow the instructions of the emergency services. Do not re-enter the building until requested to do so by the plant fire department. Accidents on the company premises must be reported to plant security.
